Course Relationships in Degree Tracker



Behind the Degree Tracker advisement report you see on your screen is an intricately woven web connecting student records, curriculum requirements, and [the course catalog](#). Whether you work with Degree Tracker to advise students or manage curriculum updates, it is important to understand the various course relationships in *and out of* the course catalog and how they affect the Degree Tracker report.

Permanently Cross-Listed Courses

A permanently cross-listed course is a single course offered collaboratively through two or more departments or programs. The course may have two or more different subjects, with the same or different catalog numbers, but they share the same course ID number, title, description, credit hours, grading basis, etc. Example: ANT 315 and BIOL 315.

Degree Tracker Status: Automatic

Equivalent Course Groups

Courses in an equivalent course group are deemed as equivalent in content and rigor, but they are technically separate courses. Any course within a group satisfies a program requirement the same as another course within that group. Unlike permanently cross-listed courses, they are not the same, but they are interchangeable. Example: The ACT 200 equivalent course group includes ACT 200 and ACT_OX 200.

Degree Tracker Status: Automatic

Ad Hoc Cross-Listed Classes (a.k.a. Cross-Listed Topics)

These are determined each semester. They are separate courses with different course ID numbers, but they have the same topic title, instructor, and class time and location. When classes are loaded into CourseLeaf/CLSS, the originating department lists each of the connected classes. This lets students know the class is the same no matter which course number they register for. However, this relationship only exists in CourseLeaf/CLSS and OPUS for registration purposes; it does not link to Degree Tracker. If your program requirements include any cross-listed topics, when you send updates to the Degree Tracker Team, you must include all connected classes, regardless of originating department. Example: The topic "Heroes, Martyrs, & Cults in Latin America" offered in Spring 2026 exists in CourseLeaf/CLSS as ANT 280R, HIST 296, LACS 270, REL 270, and SOC 289.

Degree Tracker Status: Department Must Notify
